Meeting Notes:

The meeting started with a general discussion about the timing of Phase I. It was discussed that we should not let the project timing slip more than two or three weeks due to problems it would create with the holiday season then with possible slow downs due to Y2K. At the end of the meeting it was decided to delay the next public meeting one week to September 23, 1999 at 9:00am (location TBA). And to add one additional workgroup meeting on September 16, 1999 at 9:00am at the WWTF.

In an effort to get additional stakeholder participation at the next public meeting Abeer volunteered to put a draft of a one page fact sheet together. The fact sheet would be included in the mailing for the next public meeting.

It was agreed that a provision would be added to the EMS training that would encourage EMS and P2 audits to explore opportunities at participating facilities.

A lengthy discussion was held on attachment A of the FPA. Actions items are discussed below.

The SNC approach discussion will be changed to reflect that the approach only deals with an alternative method of publishing and that information will be posted on the website.

After the meeting Andy and Dennis had a discussion with Tri of Alf Atochem it was agreed that we would attempt to add them as an industry participant. This will mean having a separate type of reduction goal (for example the goal might be to reduce BOD)
