

Romic Environmental Technologies Corporation - Southwest (Romic) is a hazardous waste storage and treatment facility on the Gila River Indian Community (GRIC) near 6760 West Allison Road, Chandler, Arizona.

### Notice of Intent to Deny a RCRA Permit Application

U.S. EPA is proposing to deny the application (EPA ID. NO.AZD009015389) from Romic Environmental Technologies Corporation – Southwest for a Resource Conservation and Recovery Act (RCRA) permit to continue to treat and store hazardous waste.

U.S. EPA intends to deny the Romic permit application because the application is lacking a land owner's (GRIC) signature and certification, as required by 40 C.F.R. §§ 270.10, 270.11. RCRA regulations require that land owners provide a signature and certification with the permit application. Prior to making a final decision, U.S. EPA is providing a 45-day public comment period that begins today.

#### **Public Comment Period**

The public comment period will **begin on August 24, 2007** and will run for 45 calendar days, **ending on October 9, 2007**. To comment, you may write, email, fax, or call the following people:
