FINDING OF NO SIGNIFICANT IMPACT

For the

Ventura County El Rio South-Central Sewer Collection Design

PROJECT LOCATION AND DESCRIPTION

The U.S. Environmental Protection Agency (EPA) awarded a Wastewater Infrastructure Grant to Ventura County for the final design of a sewer collection system El Rio South-Central area. This design includes preparation of topographic mapping, ortho-photos, construction drawings, contract specifications, and geotechnical engineering.

PURPOSE AND NEED FOR THE PROPOSED ACTION

Ventura County has proposed to install about 83,610 linear feet of new sewage collection pipeline in the El Rio area in order to terminate the use of septic tanks in the area, which can pollute local drinking water wells. This project is necessary to comply with an enforcement action brought by the California Regional Water Quality Control Board (RWQCB) to bring the water wells into compliance with State and federal standards. In addressing requirements under NEPA, the Environmental Assessment (EA) described the entire project ordered by the RWQCB, including the El Rio West portion. The project covered by this grant, however, is limited to the El Rio South-Central area, which involves about 27,000 linear feet of new pipe.

ENVIRONMENTAL CONSEQUENCES AND CONDITIONS

In compliance with the National Environmental Policy Act, EPA has prepared an EA that examines the potential environmental impacts of the proposed project. After considering a wide range of regulatory, environmental (both natural and human) and socio-economic factors, the EA did not identify any significant impacts to the environment that would result from the implementation of this project.

PUBLIC REVIEW

The EA is on file, along with other project materials, and is available for public inspection at the EPA Region 9 office in San Francisco, California.
