### FINDING OF NO SIGNIFICANT IMPACT

# Russian River County Sanitation District Third Unit Processes Project

## **Project Location and Description**

The Sonoma County Water Agency (SCWA) on behalf of the Russian River Sanitation District (RRCSD) has requested \$451,400 from the United States Environmental Protection Agency (EPA) to fund the construction of the Third Unit Processes Project (TUPP) for the RRCSD's wastewater treatment facility in the unincorporated community of Guerneville, California. The EPA is considering fulfilling this funding request.

The TUPP would improve the RRCSD wastewater treatment facility's ability to treat high winter influent flows. The TUPP would include the construction of a third aeration basin, a third secondary clarifier and a replacement tertiary filter system. The construction would all take place on the existing RRCSD property. The TUPP would not increase the RRCSD's wastewater treatment facility's permitted effluent discharge levels.

### **Purpose and Need for the Proposed Action**

During significant flood events on the lower Russian River, the amount of sewage received by the RRCSD wastewater treatment facility (influent) exceeds the facility's treatment capacity. This has caused the wastewater treatment facility to discharge partially treated wastewater (effluent) to the Russian River. This is especially an issue when large flood events occur during the more restrictive summer discharge season; May 15 through September 30. According to the RRCSD's NPDES permit, during the summer discharge season, the RRCSD wastewater treatment plant may not discharge to the Russian River, and must discharge only through land irrigation. When the RRCSD wastewater treatment plant violates its NPDES permit, this leads the North Coast Regional Water Quality Control Board (NCRWQCB) to issue Cease and Desist Orders to the RRCSD.

The purpose of the proposed action is: 1) to reliably treat and adequately dispose of permitted wastewater flows during high influent flow periods, particularly during flood events on the lower Russian River; 2) to comply with the NCRWQCB Cease and Desist Orders; and 3) to minimize future discharge violations.

#### **Environmental Consequences**

An Environmental Assessment was prepared in conformance with the National Environmental Policy Act (NEPA). This EA was circulated for a 30 day public review period; from January 21, to February 21, 2003. As a result of the EA, as well as public discussion of the proposed project, the EPA has determined that the action will not have a significant impact on the quality of the environment.
