EPA Brownfields RLF Grants

- Up to \$1 Million grant*
- Requires 20% match
- Hazardous Substances & Petroleum
- Funding provided to capitalize a revolving loan fund and to provide subgrants to carry out cleanup activities at brownfields sites

* An eligible entity may apply for \$1 million. EPA will accept proposals submitted by “coalitions” (groups of eligible entities) to pool their revolving loan capitalization grant funds. Under a coalition proposal, each eligible entity may apply for up to \$1 million.



EPA Brownfields RLF Grants

RLF

RLF Loan

- 60%
- Provide no-interest or low interest loans for Brownfields Cleanups

Cleanup Sub-Grant

- 40%
- Do not require repayment
