This letter is written to you in your capacity as the designated project coordinator for the removal action performed pursuant to the Second Administrative Order for Removal Action, CERCLA Docket No. CERCLA-1-2001-0032 (the "Order"), which was signed by the Director of the Office of Site Remediation and Restoration on March 26, 2001.

EPA hereby approves the Completion of Work Report submitted by Loureiro Engineering Associates ("LEA") on April 7, 2005. EPA has determined that the Respondents have fully performed all work in accordance with the Order and subsequent amendments, and all Performance Standards and goals of the Order and the Scope of Work ("SOW") have been satisfied (with the exception of the performance of Post Removal Site Controls).

Please be advised that this determination does not constitute a release from liability, covenant not to sue, or waiver of any claims which EPA may have against the Respondents. In addition, be advised that this determination does not limit EPA's authority under CERCLA or any other law to conduct future response actions at the Centredale Manor Restoration Project Superfund Site. EPA reserves all rights with respect to the Site including, but not limited to, the right to initiate judicial or administrative enforcement actions, the right to recover costs incurred by the United States in connection with the Site, and the right to undertake further response actions and recover the costs of such actions from the Respondents or any other responsible parties. Finally, please note that Respondents are subject to other continuing obligations pursuant to the Order (e.g. record preservation).

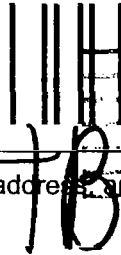
