Thank you for participating in interviews with Marion Cox, the neutral facilitator hired by EPA to explore the possibility of establishing a dialogue among interested parties in connection with the future cleanup of the Centredale Manor Restoration Project Superfund Site. We believe that Ms. Cox's interviews have elicited helpful information and input from both the potentially responsible parties and the community.

We have reviewed Ms. Cox's report and concluded that the majority of the parties interviewed would like additional information about the potential cleanup alternatives before participating in the proposed discussions. EPA expects to have that information available later this Fall. Therefore, we have decided to defer the proposed dialogue until that time. In the meantime, however, I will be considering the additional comments the potentially responsible parties made concerning enforcement matters and continuing to investigate whether additional entities should be identified as potentially responsible parties.
