Introduction to the Collection

This is the Administrative Record for the Centredale Manor Restoration Project Site, North Providence, Rhode Island, Removal Action Addendum 3. This Administrative Record was compiled in October 2006 and subsequently released on CD-ROM in November 2010. This Administrative Record contains site-specific documents and a list of guidance documents used by EPA staff in selecting a removal action at the site.

On 11 September 2003, EPA issued an Administrative Order on Consent (AOC) to 10 Potentially Responsible Parties (PRPs) for implementation of actions to reduce the potential for migration of, and direct contact with contaminated soils and sediments within the area of the former tailrace on the eastern edge of the site. The contaminants include dioxin, polychlorinated biphenyls (PCBs), volatile organic compounds (VOCs), and semivolatile organic compounds (SVOCs). Removal actions undertaken by the PRPs' contractor include the following: reconstructing the tailrace to prevent migration of contaminated surface soil and sediments; incorporating a protective cap to stabilize the contaminated soils and sediments in the tailrace; and incorporating a drainage swale to mitigate stormdrain runoff flowing into the tailrace from route 44A.
