Introduction to the Collection

This is the Administrative Record for the Peterson/Puritan Inc. Superfund Site, Cumberland and Lincoln, Rhode Island, Operable Unit (OU) 2 Removal Action, dated September 26, 1991. This action consisted of the removal of an exposed drum and the erection of a fence to prohibit public access to the site.
