We have listed Legacy Beatrice financial reports as an important resource for our current investors, which are for research and continuity purposes between the predecessor and successor Beatrice entities.

Legacy Beatrice= 1894-1990

New Beatrice= 2007-current

A Brief Historical Breakdown

- 1894: Founded as 'Haskell and Bosworth'
- 1898: Incorporated as 'Beatrice Creamery Company'
- 1946: Beatrice Creamery changes its name to 'Beatrice Foods Company'
- 1984: Beatrice Foods changes its name to 'Beatrice Companies, Inc.'
- 1984: Beatrice Companies acquires Esmark, Inc.
- 1986: Kohlberg, Kravis and Roberts (KKR) acquire Beatrice Companies, and spend the next four years dismantling the company
- 1986: KKR changes the name of Beatrice Companies to BCI Holdings Corporation
- 1987: BCI Holdings spins-off Beatrice Consumer Products Corporation which becomes 'E-II Holdings'
- 1987: BCI Holdings sells the original company business operations, Beatrice Dairy Products, Inc. to Borden, Inc.
- 1987: Beatrice International Foods, which included Beatrice Foods Canada Ltd., sold to corporate attorney, Reginald Lewis
- 1987: KKR renames BCI Holdings Corporation to 'Beatrice Company'
- 1990: KKR sells Beatrice Company to ConAgra, Inc.
- 1991: Hoopes Enterprises, Inc. is incorporated
- 1999: Hoopes Enterprises introduces Virtual Open House (VOH.Com), at the time, an innovative 360° panorama virtual tour real estate directory listing service
- 2000: Hoopes changes name to 'Almus, Inc.', which is Latin for "bountiful food"
- 2007: Almus changes its corporate charter and becomes 'Beatrice Companies, Inc.'; "The New Beatrice"
