ANNOUNCEMENT OF PROPOSED PERMIT AND PUBLIC HEARING, AND REQUEST FOR PUBLIC COMMENT OF PROPOSED CLEAN AIR ACT GREENHOUSE GAS PREVENTION OF SIGNIFICANT DETERIORATION PRECONSTRUCTION PERMIT

Public Comment Period January 16, 2013 to February 15, 2013

The United States Environmental Protection Agency (EPA) provides notice of and requests public comments on the EPA’s proposed action relating to the Prevention of Significant Deterioration (PSD) permit application for the Copano Processing, L.P., Houston Central Gas Plant. If finalized, the EPA’s issuing of a PSD permit would regulate greenhouse gas (GHG) pollutant emissions associated with the construction of a new 400 MMSCF/day cryogenic process train (Cryogenic 3 Process Unit) in accordance with the PSD regulation (40 CFR 52.21). The proposed construction will occur at the existing facility, Houston Central Gas Plant which is located at 1650 County Road 255 South, Sheridan, TX 77475.

Under the provisions of 40 CFR 52.21 (except paragraph (a)(1)), EPA Region 6 implements a greenhouse gas PSD Federal Implementation Plan (FIP) for Texas. See 40 CFR 52.2305. As the proposed project represents a major modification to an existing major source and significant increase in greenhouse gas (GHG) emissions as described at 40 CFR 52.21 (b)(49)(iv), EPA concludes that Copanos’ application is subject to PSD review for the pollutant GHG emissions. The construction of the Cryogenic 3 Process Unit covered by the draft permit is composed of the following emission sources: combustion turbines, heaters, regenerative thermal oxidizer, and process fugitives.

Any interested individual may submit written comments on EPA’s proposed PSD permit for the Copano Processing project. All comments must be received in writing by February 15, 2013 or postmarked by February 15, 2013 to Aimee Wilson at one of the following addresses:

All comments on the draft permit must be received by email or postmarked by February 15, 2013 to the respective address above. EPA will consider and respond to all comments in making the final decision regarding the issuing of the permit. Similar comments may be grouped together in the response, and the EPA will not respond to individual commenters directly.

Additionally, all comments will be included in the administrative record without change, and may be made available to the public, including any personal information provided, unless the comment includes Confidential Business Information (CBI) or other information whose disclosure is restricted by statute. Thus, CBI or other protected information should be clearly identified as such, and should not be submitted through email. Emails sent directly to the EPA will capture your email address automatically and will be included as a part of the public comment. *Please note that an email or postal address must be provided with your comments if you wish to receive responses to comments submitted during the public comment period and direct notification of EPA’s final decision regarding the permit.*

An extension of the 30-day comment period may be granted if the request for an extension adequately demonstrates why additional time is required to prepare comments.

**Public Hearing:** If EPA determines that there is a significant amount of public interest in the draft permit, the EPA has the right to hold a public hearing. Any request for a public hearing must be received by the EPA either by email or mail by February 8, 2013, and must state the nature of the issues proposed to be raised in the hearing. Attendance at the public hearing is not required in order to submit written comments. *If the EPA determines that there is significant public interest*, a public hearing will be held on February 27, 2013 from 6:00 p.m. to 8:00 p.m. at the following location:

If a public hearing is held, the public comment period shall automatically be extended to the close of the public hearing. The EPA maintains the right to cancel a public hearing if no request for a public hearing is received by February 8, 2013, or the EPA determines that there is not a significant interest. *If the public hearing is cancelled*, notification of the cancellation will be posted by February 12, 2013 on the EPA’s Website <http://yosemite.epa.gov/r6/Apermit.nsf/AirP>. Individuals may also call the EPA at the contact number listed above to determine if the public hearing has been cancelled.

**Permit Documents:** EPA’s draft permit, EPA’s preliminary determination and statement of basis, Copano Processing’s permit application and supporting documentation, and comments received from the public, other government agencies, and the applicant during the public comment period become part of the administrative record for the permit. In addition, all data submitted by the applicant is available as a part of the administrative record. **Final Determination:** A final decision to issue a permit or to deny the application for the permit shall be made after all comments have been considered. Notice of the final decision shall be sent to each person who has submitted written comments or requested notice of the final permit decision, provided the EPA has adequate contact information.
