Public Comment Period March 21, 2012 - April 21, 2012

The United States Environmental Protection Agency (EPA) provides notice of and requests public comment on the EPA's proposed action relating to the Prevention of Significant Deterioration (PSD) permit application for the ETC Jackson County Gas Plant. EPA is issuing notice of a draft PSD permit for the ETC facility that if finalized would regulate the greenhouse gas air pollutant emissions associated with the project to construct four natural gas processing plants and associated compression equipment in accordance with the PSD regulation (40 CFR 52.21). The project is located near Ganado, TX 77962 at the following coordinates: 29°0'34.46" N, -96°32'15.52" W. EPA concludes that ETC's application is subject to PSD review for the pollutant GHGs, as the project will result in increased greenhouse gas emissions for a facility described at 40 CFR 52.21 (b)(49)(iv). The proposed project consists of the construction of four natural gas processing plants and associated compression equipment. Each of the four natural gas processing plants is in turn comprised of the following emissions sources: two
