ATTORNEY GENERAL'S STATEMENT FOR FINAL AUTHORIZATION FOR CHANGES TO THE FEDERAL RCRA PROGRAM FROM JANUARY 1983 THROUGH JUNE 1996

I hereby certify, pursuant to my authority as Attorney General of the State of Louisiana and in accordance with Section 3006(b) of the Resource Conservation and Recovery Act, as amended by the Hazardous and Solid Waste Amendments of 1984 (42 USC 6901 et seq.), and 40 CFR 271 that in my opinion the laws of the State of Louisiana provide adequate authority to carry out the revised program set forth in the revised "Program Description" submitted by the Louisiana Department of Environmental Quality. The specific authorities provided are contained in statutes or regulations lawfully adopted at the time this Statement is signed and which are in effect now as specified below. These authorities and this certification supplement the previously certified authorities described in my certification of June 17, 1996.

The State of Louisiana was previously granted authorization for most of the checklists contained in clusters referred to by the United States Environmental Protection Agency (U.S.E.P.A.) as Base Program, non-HSWA I, non-Hswa II, non-Hswa III, non-HSWA IV, non-HSWA V, non-HSWA VI, HSWA I, HSWA II, RCRA I, RCRA II, and RCRA III. This Attorney General's statement coincides with the rules addressed in checklist 85 in the cluster referred to by the U.S.E.P.A. as RCRA I, checklists 94 and 96 in the cluster referred to by the U.S.E.P.A. as RCRA II, checklists 111 and 114 in the cluster referred to by the U.S.E.P.A. as RCRA III, checklists 125-134 in the cluster referred to by the U.S.E.P.A. as RCRA IV, checklists 135-144 in the cluster referred to by U.S.E.P.A. as RCRA V, and checklists 145-152 in the cluster referred to by U.S.E.P.A. as RCRA VI.

Remarks of the Attorney General

LAC 33:V.2201.G.4.b is more stringent than 40 CFR 268.1(c)(3)(ii), the federal equivalent, because it clarifies the point of injection by specifically stating "at the well head."

40 CFR 268.7(a)(10) had no analog in Louisiana regulations because the state does not have tolling agreements and is therefore more stringent.

XXI. LAND DISPOSAL RESTRICTIONS

LAC 33:V.3901, 3903, 3911, 3913, and 3915 are more stringent than 40 CFR 261.5(b), (c),(e), (f)(2), and (g)(2), the federal equivalents, because the SQG's are regulated more stringent in Louisiana than in the above mentioned federal citations.

LAC 33:V.2237.A.3.b.i is more stringent than 40 CFR 268.4(a)(3)(ii)(A), the federal equivalent, because Louisiana additionally requires one compacted clay or other LDEQ approved liner in addition to the federal requirements.

LAC 33:V.2239.A.1-4 are more stringent than 40 CFR 268.5(a)(1-4), the federal equivalent, because Louisiana specifically requires written evidence of a good faith effort to manage waste.



LAC 33:V.2201.G.4.b is more stringent than 40 CFR 268.1(c)(3)(ii), the federal equivalent, because it clarifies the point of injection by specifically stating "at the well head."

LAC 33:V.2231.A is more stringent than 40 CFR 268.44(a) because the state requires the petitioner to bear the burden of proving that the properties of the waste differ significantly from wastes analyzed in the treatment standards.


