Remarks of the Attorney General

LAC 33:V.1109.E.7.a is more stringent than 40 CFR 262.34(d)(2) because LDEQ does not recognize conditionally exempt small quantity generators. If a person generates "greater than 100 kg but less than 1000 kg" in this state, the generator is the equivalent of a large quantity generator and would follow more regulations for LQG. Additionally, the federal citation lists the accumulation time as 180 days or less and the state citation lists the accumulation time as 90 days or less.

XVI. REQUIREMENTS FOR PERMITS

BB. This is a reduced requirement. State statutes and regulations include requirements for hazardous waste combustion facility permit modifications to meet 40 CFR part 63 MACT standards, as indicated in Revision Checklist 168. State statutes and regulations also address such changes during interim status.
