# ATTORNEY GENERAL'S STATEMENT FOR FINAL AUTHORIZATION FOR CHANGES TO THE FEDERAL RCRA PROGRAM FROM JULY 2002 THROUGH JUNE 2005 RCRA CLUSTER XIV

I hereby certify, pursuant to my authority as Attorney General of the State of Louisiana, through undersigned counsel and in accordance with Section 3006(b) of the Resource Conservation and Recovery Act, as amended by the Hazardous and Solid Waste Amendments of 1984 (42 USC 6901 et seq.), and 40 CFR 271 that in my opinion the laws of the State of Louisiana provide adequate authority to carry out the revised program set forth in the revised "Program Description" submitted by the Louisiana Department of Environmental Quality. The specific authorities provided are contained in statutes or regulations lawfully in effect at the time this Statement is signed. The regulatory provisions for which the state of Louisiana is seeking authorization are documented in the attached Revision Checklists 203 and 205 (See Attachment I). The state and EPA representatives have identified areas in the state hazardous waste regulations that have been amended or applied department wide that have not received authorization. (See Attachment 2). These items are submitted in this package requesting authorization. Differences between the state of Louisiana provisions and the Federal provisions are noted on the Revision Checklists 203, and 205, and the identified areas in the state hazardous waste regulations that have been amended or applied department wide that have not received authorization. The State regulations may be found in the Environmental Regulatory Code produced by the Louisiana Department of Environmental Quality, ERC Title 33, Part V. Hazardous Waste and Hazardous Materials, 2005 edition. This certification supplements my or my predecessor's certification of October 20, 2004.

### STATUTORY CERTIFICATION

I hereby certify that statutes addressed in previous authorization applications submitted to the Environmental Protection Agency have not been amended, modified or revised. Revisions have been made to the Statutes, but none that specifically affect the RCRA program. The statutory authorities for the State of Louisiana are documented in the Louisiana RCRA Statutory Checklist (Attachment 3), dated August, 2002.
