A. GENERAL INFORMATION

1. Statement

The laws of the State of Texas provide authority that is equivalent to, and no less stringent than, the designated minor rules or parts of rules specified in an update to Table 1 of 40 C.F.R. § 271.21 provided by the Environmental Protection Agency (EPA) in the April 28, 1999 Memo from Elizabeth A. Cotsworth to RCRA Senior Policy Advisors, Regions I-X. As required by 40 C.F.R. § 271.21(h)(1) (related to abbreviated authorization revisions), copies of all applicable statutes and rules are provided. The specific authorities provided are contained in statutes or regulations lawfully adopted at the time this statement is signed and which are now in effect.

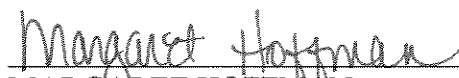
