Emergency Community Water Assistance Grants (ECWAG)

Program Overview

The Emergency Community Water Assistance Grants (ECWAG) program helps eligible rural communities recover from or prepare for emergencies that result in a decline in capacity to provide safe, reliable drinking water for households and businesses. Water quality or quantity may be impacted. A federal disaster declaration is not required.

What kind of event can qualify as an emergency?

- Drought or flood.
- Earthquake.
- Tornado or hurricane.
- Disease outbreak.
- Chemical spill, leak or seepage.
- Other disasters.
 NOTE: A federal disaster declaration is <u>not</u> required.

How may the funds be used?

- Grants up to **\$150,000** are for repairs to breaks or leaks in existing water distribution lines, and related maintenance.
- Grants up to **\$500,000** are for construction of a new water source, intake and/or treatment facility or waterline extensions.

Eligible Areas

- Rural areas and towns with 10,000 or fewer people. Check eligible addresses at http://eligibility.sc.egov.usda.gov.
- Federally recognized Tribal Lands.
- Colonias.
 NOTE: The area to be served must also have a median household income less than California's median household income for non-metropolitan areas which is \$62,883.

Eligible Applicants

- Most State and local governmental entities.
- Nonprofit organizations.
- Federally recognized Tribes.
 NOTE: Privately owned wells are not eligible.

How to Apply

Applications are accepted year round through the local USDA Rural Development office. For a list of offices and staff contact information, see other side.
