Air Division Update

Tribal Air Funding


- Region 9 received 36 applications for FY 2011 tribal Clean Air Act (CAA) funding.
- Region 9 is evaluating the applications and will notify tribes of their funding status in Spring 2010.

Pinal Particulate Matter Redesignation (PM10 and PM2.5)

- Region 9 is working to redesignate Pinal County for PM10 and PM2.5.
- Pinal County has violated the PM10 standard since 2002, and the PM2.5 standard in 2006.
- If Pinal is designated nonattainment, Pinal and ADEQ will need to develop a state implementation plan (SIP).
- Region 9 has done outreach to tribes with lands located in Pinal County and encourages their continued participation in the process.

New Ozone (O3) Standard

- On January 6, 2010 EPA proposed to strengthen the Ozone standard.
 - Proposed primary standard: .060-.070 ppm,
 - Proposed secondary standard: 7–15 ppm-hours
 - 2008 standard was .075 ppm primary and secondary.
- ▶ Public comment period is Jan. 19–March 22, 2010.
 - Hearings in Arlington, VA; Houston, TX; and Sacramento, CA February 2-4, 2010.
- Many Region 9 tribes may be impacted (see map).
- ▶ EPA will issue final standards by August 31, 2010.
- Attainment and nonattainment recommendations from Tribes and States on the new standard will be due January 2011.
- Designations process will be completed by August 2011.

BART Determination for Navajo Power Plants

- ▶ EPA is responsible for determining the Best Available Retrofit Technology (BART) for two coal-fired power plants on Navajo Nation.
- In August 2009, EPA issued an Advanced Notice of Proposed Rulemaking (ANPR) requesting public comment on anticipated visibility improvement and cost effectiveness of controls.
- Region 9 is aware of the concerns of many Arizona tribes related to Navajo Generating Station and the Central Arizona Project.
- The time period for government-to-government consultations with tribes on the ANPR has been extended until March 1, 2010.
- The ANPR is the first step in the process. There will be several more steps with opportunities for tribal comments and consultation.

Funding Opportunity Tribal Public Water System Supervision Source Water Assessment & Protection Program (SWAP)

- PURPOSE: to enable federally recognized tribes and eligible tribal consortia within EPA Region 9, who operate at least one public water system (PWS), to identify and assess any possible threats (potential sources of contamination) to their public drinking water supply sources and to develop protection measures to protect these sources against those threats.
- ▶ EPA received a total of 3 proposals during the October– December, 2009 submission period.
- Tribes seeking 2010 SWAP DITCA funding must submit proposals by March 31, 2010.



Lead Hazard Update

- Region IX Toxics Office is developing a 10-year "inventory" of lead-based paint activities conducted at Region IX tribes since 1999.
- Inventory will identify activities conducted by tribal governments; EPA; BIA; IHS; HUD; and other Federal agencies.
- Inventory will allow tribal governments to identify where lead work needs to be done and where resources (such as grant funding) could be focused.

Lead Hazard Update

- Toxics Office is also preparing tool kit/resource guide/contact list with information on applicable Federal lead hazard requirements; Federal grant funding sources; and Federal agency contacts in Region IX on lead hazard issues.
- Approximately 20 Region tribes have conducted lead activities since 2000, while 125 tribes have not conducted such activities.
