The authors of the above-referenced study suggest that DDE levels in serum, together with certain genetic markers, could help with early identification of people at high risk for Alzheimer's. Their work could also lead to avenues of Alzheimer's treatment. Even though the study was funded by NIH, the article about the study is copyrighted and is not releasable by third parties (like EPA). You may be able to get a free copy of the article about the study by contacting the author directly or going through a library that has a subscription with the journal that published the article (JAMA Neurology). It appears as if a copy of the article can be purchased from JAMA Neurology.
