Figure D-1. Owner of the Boat (Q1)



Figure D-2. Length of Boat (Q2)



Figure D-3. Draft of Boat (Q3)




Figure D-4. Function of Boat (Q4)



Figure D-5. Type of Boat (Q5)



Figure D-6. Type of Toilet in Boat (Q6)



Figure D-7. Type of Installed Toilet in Boat (Q7)



Figure D-8. Service and Performance of Installed Toilet (Q8)



Figure D-10. Length of Training for Proper Use (Q10)




Figure D-12. Number of Days Boated in the 2003 Season (Q12)



Figure D-13. Number of Days Boated in the NDZ in the 2003 Season (Q13)



(Q14)



Figure D-15. Arrangement with Marina to Pump Out Tank During Boater Absence (Q15)



(Q16)



Figure D-17. Number of Times Pumpout or Toilet Dump Facility was Used in 2003 (Q16A)



Figure D-18. Trouble with a Pumpout or Toilet Dump Facility in 2003 (Q17)



Figure D-19. Number of Times a Boater had Trouble with a Pumpout or Toilet Dump Facility (Q17A)



Figure D-20. Trouble with the Pumpout or Toilet Dump Facilities on Last Trip in NDZ (Q18)



Figure D-21. Could Not Find Working Pumpout or Toilet Dump This Season in NDZ (Q19)



Figure D-22. Discharged Sewage Outside the NDZ (Q20)



Figure D-23. Number of Times Boater Discharged Sewage Outside the NDZ (Q20A)



Figure D-24. Conditions Found at Pumpout or Toilet Dump Facilities in the NDZ in 2003 (Q21)




Figure D-26. Number of Times Conditions or Problems Deterred Boater from Using Facilities (Q22A)



Figure D-27. Knowledge Whether or Not Designated Area is an NDZ (Q23)



Figure D-28. Knowledge that Discharge of Vessel Sewage is Prohibited in the NDZ (Q24)



Figure D-29. Source of Information about NDZ (Q25)



Figure D-30. Organization that Boater Believes has Responsibility to Enforce NDZ (Q26)



Figure D-31. Aware of Anyone Receiving Citation for Discharging Sewage in NDZ (Q27)




Figure D-33. Length of Boat (feet) by Whether Pumpout Facility Was Used (Q2 by Q16)



Figure D-34. Draft of Boat (feet) by Whether Pumpout Facility Was Used (Q3 by Q16)



Figure D-35. Function of Boat by Whether Pumpout Facility Was Used (Q4 by Q16)



Figure D-36. Type of Boat by Whether Pumpout Facility Was Used (Q5 by Q16)



Figure D-37. Type of Toilet Operated by Whether Pumpout Facility Was Used (Q6 by Q16)



Figure D-38. Source of Training by Whether Pumpout Facility Was Used (Q9 by Q16)




Figure D-39. Frequency of Boating in NDZ (days) by Whether Pumpout Facility Was Used (Q13 by Q16)



Figure D-41. NDZ Year of Origination by Whether Pumpout Facility Was Used (NDZ Age by Q16)



Figure D-42. Length of Boat (feet) by Whether Boater had Problems (Q2 by Q17)



Figure D-43. Draft of Boat (feet) by Whether Boater Had Problems (Q3 by Q17)



Figure D-44. Function of Boat by Whether Boater Had Problems (Q4 by Q17)





Figure D-46. Type of Toilet Operated by Whether Boater Had Problems (Q6 by Q17)



Figure D-47. Source of Training by Whether Boater Had Problems (Q9 by Q17)



Figure D-48. Frequency of Boating in NDZ (days) by Whether Boater Had Problems (Q13 by Q17)





Figure D-49. Adverse Conditions Experienced by Boater by Whether Boater Had Problems (Q21 by Q17)


Figure D-50. Adverse Conditions Experienced by Boater by Whether Boater Had Problems (Q21 by Q17)

Figure D-52. NDZ Year of Origination by Whether Boater had Problems (NDZ Age by Q17)




Equipment (Q20 by Q22)


